The St. Joseph County Human Services Commission (HSC) was established by the St. Joseph County Commission in 1995 as the single mulit-purpose collaborative for St. Joseph County. Their resolution authorized SJC Human Services Commission to:

- Forge alliances
- Create a shared vision
- Mobilize resources for services to families whose needs are being met by multiple agencies

Currently HSC is comprised of 16 member agencies working together to coordinate health and human services across systems. HSC fosters collaboration and relationships among agencies to prevent duplication of services and provide better service to our citizens.

The HSC does this work through established task forces and workgroups.



SJC Resource / Referral Guide


A comprehensive **Resource/Referral Guide** was developed within the task forces / workgroups for front line workers and published on the HSC website June, 2017.*

Project Connect 2017

Project Connect is a collaboration of the SJC Human Services Commission, its task forces, and other agencies serving St. Joseph County. The 11th Annual Project Connect was held October 6th at Firm Foundations Ministries in Centreville. It was held in conjunction with a Veteran Stand Down.

Event Impact:

- 288 households attended
- 759 persons were Impacted (includes household members not present)
- 93% of attendees reside within St. Joseph County
- 195 out of 200 households indicated they received the help they needed
- 125 new households attended that did not attend in 2016
- 160 of the households attending in 2016 did not return to 2017 Project Connect
- 89 veterans attended
- Average household size was 3 persons
- Average age of attendee was 46-55 years old
- 16% of households had less than 12 years of education
- 22 households currently homeless
- 20 households in process of being evicted
- 86 attendees currently unemployed
- Typical wage of attendees was \$9-\$11/hour
- 52% of attendees sought food assistance
- 21% of attendees sought healthcare assistance

Project Connect is a community resource fair for individuals and families who are low income, homeless, and/or veterans to give them a hand up and improve their quality of life. Free items, services, information, and help is available on site at this one day event.

At 2017 Project Connect:


- 40 rides provided to and from event courtesy of SJCTA
- 450 meals served
- 50 haircuts provided
- 70 service agencies participated
- 300 hygiene kits provided
- 300 community help cards distributed
- 400 food boxes distributed
- 194 shots administered
- 319+ health screenings provided



Collaboratively accomplished:

- ♦ Upgraded StepUpSJC.net to include interviews with local health champions provided as a county leadership team project.
- Monthly WBET morning show broadcast and newspaper articles of health topics.
- ♦ Visited 10 civic groups and the County Commission to present the Community Health Needs Assessment results.
- Updated 5 fact sheets for SJC based on Community Health Needs Assessment findings.
- ♦ Formed an ad hoc health events group to evaluate current health events countywide, determine whether the major health concerns of the Community Health Needs Assessments are being addressed at these events, and discuss how these health events can be improved.
- Started a pilot child exercise program piggy backing off of summer lunch program in Sturgis.

Collaboratively accomplished:

- ♦ Elder Abuse Red Flags/ Senior Reach Grant
 - 1164 people trained (1005 non-traditional community partners)
 - 56 referrals for services
 - ⇒ 61% referrals came from non-traditional sources
 - ⇒ 87.1% of referrals who were eligible for services, accepted services offered to them
 - Vulnerable Adult Interdisciplinary Team
 - ⇒ 14 cases reviewed
- Nine community partner presentations at task force meetings
- ♦ 55 community partners trained at ASN Human Trafficking event
- ♦ 61 community partners involved in the ASN google group and 20 regularly attend the monthly meetings

Three ramps were built through the Adult Services Network's Ramp Initiative this year for citizens who otherwise would not qualify for ramps. The COA took the lead of this successful grass roots effort to create a pool of resources for ramps (materials, labor, money) so people can get in and out of their homes.

This interdisciplinary team of medical staff, law enforcement, and other professionals review child deaths within St. Joseph County to determine if these deaths of 0-18 years olds were preventable. When appropriate, they suggest community wide prevention education to prevent future deaths.

- ♦ 11 cases were reviewed in 2017.
- ♦ Lack of safe sleep practices, lack of prenatal care, and drowning contributed to preventable deaths occurring in 2017.

Collaboratively accomplished:

The SJC Great Start Collaborative/Early Childhood Workgroup completed its year long strategic plan process and will begin implementing the new 4 year strategic plan.

- ♦ Sponsored Family Fun Day − 17 agency partners participated − free books and a "Build an Edible House activity" for 175 children.
- ♦ Created the "Great Start Reading Cart."
- Increased 3 year old preschool scholarships in St. Joseph County from 2 to 28.
- Increased partnerships with 7 childcare/preschool providers.
- Provided Quality childcare training for 18 attendees.
- Conscious Discipline book study for 125 participants.
- ♦ Hosted two Jim Henry Trauma Trainings (280 attendees).
- Welcome baby bags distributed to new families at Three Rivers, Sturgis, and Bronson hospitals bags include local resource information for parents.
- Held two community baby showers with safe sleep and shaken baby syndrome trainings. 70 families were educated.

124 homeless people on Point in Time Count Day

- ♦ 792 literally homeless people in St. Joseph County in 2017
- ♦ 517 children served in shelter with average age of 6 years old
- ♦ 159 people served with rent/shelter assistance, equaling \$181,277.95
- ♦ 338 households served with utility assistance equaling \$161, 868.56
- ♦ Emergency housing assistance provided for over 500 people
- Over 500 cases coordinated through Interagency Services Team with focus of minimizing barriers to help people get housed and stay housed
- Used Mental Health grants to house 31 households with severe and persistent mental illness
- The rate of people returning to shelter this year increased to 24% (from 20% in 2016) due to the elderly population over age 65 returning to the shelter for assistance.
- ♦ 759 people impacted through Project Connect

Collaboratively accomplished:

Held 4 campaigns in FY 16/17: RX Drugs, Underage Alcohol Use, Methamphetamine, and Underage Marijuana Use; and 1 campaign in FY 17/18: RX Drug Misuse

- Grew email reach to 400 community members and front line workers.
- Provided education to 35 alcohol/tobacco retailers:
 - ♦ 18 tobacco Compliance checks completed
 - ◆ 15 Alcohol compliance checks with local law enforcement
- Held 2 Naloxone trainings in FY16/17–65 kits were distributed
- ◆ FY 16/17 Community Marijuana Forum— 54 individuals attended
- ♦ FY16/17 Voices of Recovery— Meth 110+ attended
- ◆ FY 17/18 Opiate Forum at Glen Oaks—83 attendees attended
- ◆ FY 17/18 Voices of Recovery —Prescription Drug—54 attended
- FY17/18 Conducted its first student poster contest to engage students across seven districts in prescription drug campaign. 25 posters were submitted from three school districts.
- ♦ Collected 600 pounds of prescription drugs at prescription drug take back boxes during FY2016-2107
- Collected an additional 260 pounds at October 2017 DEA National Prescription Drug Take Back Day

Strategic Planning

The St. Joseph County Human Services Commission Membership engaged in strategic planning with consulting firm Omni Tech International, Ltd to determine how our collaborative can best serve the people of St. Joseph County.



The Process

The process included engaging membership, task forces, additional agency front line workers, and other community stakeholders in a community needs survey. This survey was completed by 147 stakeholders across St. Joseph County, a sampling used to gauge opinions of where the HSC needs to position itself.


Membership met for a retreat to discuss the community survey results as well as membership's overall satisfaction of the collaborative's performance. Omni Tech then wrote a Strategic Plan with the results.

Implementing a Strategic Plan for 2017-2020

While much of our strategic plan focuses on changes internally to strengthen communication within our collaborative as well communication with other bodies and agencies in SJC, the end result will be more residents receiving services because both the front line workers serving them know what is available in our county and residents will know how to access these services.
