
#### The SJC Resources Google Email Group was

# 2018 Project Connect & Veteran Stand Down

Project Connect is a collaboration of the SJC Human Services Commission, its task forces, and other agencies serving St. Joseph County. The 12th Annual Project Connect was held October 5<sup>th</sup>,2018 at the Centreville Fairgrounds in Centreville. It was held in conjunction with a Veteran Stand Down.

#### **Event Impact:**

- 368 households attended
- 1015 persons were Impacted (includes household members not present)
- 89% of attendees reside within St. Joseph County
- 328 out of 332 households indicated they received help they needed or were connected to a resource to help with their current needs
- 255 new households attended that did not attend in 2017
- 206 households attending in 2017 did not return to 2018 Project Connect
- 89 veterans attended
- Average household size was 3 persons
- Average age of attendee was 46-55 years old
- 22% of households had less than 12 years of education
- 22 households currently homeless
- 14 households in process of being evicted
- 79 attendees currently unemployed
- Typical wage of attendees was \$9-\$11/hour
- 71% of attendees sought food assistance
- 21% of attendees sought healthcare assistance

Project Connect is a community resource fair for individuals and families who are low income, homeless, and/or veterans to give them a hand up and improve their quality of life. Free items, services, information, and help is available on site at this one day event.

#### At 2018 Project Connect:

- 38 rides provided to and from event courtesy of SJCTA
- 500 meals served
- 99 haircuts provided
- 80 service agencies participated
- 429 hygiene kits provided
- 429 community help cards distributed
- 2,356 pounds of fresh food distributed through Fresh Food Initiative
- 405 food boxes distributed
- 191 shots administered
- 317+ health screenings provided

- Documented a snapshot of Access to Healthcare through the years and the strides in access in St Joseph County over the years for a Health Prize Grant application.



This interdisciplinary team of medical staff, law enforcement, and other professionals review child deaths within St. Joseph County to determine if these deaths of 0-18 years olds were preventable. When appropriate, they suggest community wide prevention education to prevent future deaths.

- ♦ 10 cases were reviewed in 2018.
- ♦ Lack of safe sleep practices, lack of prenatal care, prematurity, domestic violence, and suicide contributed to preventable deaths of children occurring in 2018.

The SJC Great Start Collaborative/Early Childhood Workgroup continued implementing its 4 year strategic plan.

- ♦ Sponsored Family Fun Day 20 agency partners participated 121 children participated. 400+ attended
- Awarded 33 preschool scholarships for three year olds in St. Joseph County (FY17/18)

- ♦ 4 Playgroups each week in four different communities

- ♦ 122 homeless people on Point in Time Count Day
- ♦ 596 literally homeless people served in St. Joseph County in 2018
- 366 children served in shelter with average age of 7 years old
- ♦ 289 people served with rent assistance, equaling \$133,540.00
- ♦ 349 households served with utility assistance equaling \$123, 959.50
- ♦ Emergency housing assistance provided for over 700 people
- Over 500 cases coordinated through Interagency Services Team with focus of minimizing barriers to help people get housed and stay housed
- Used Mental Health grants to house 20 households with severe and persistent mental illness
- The rate of people returning to shelter this year stayed at 24%
- ♦ The elderly population entering shelter continues to increase
- ♦ 1015 people impacted through Project Connect

#### Collaboratively accomplished:

Held 4 campaigns in FY 17/18: RX Drugs, Underage Alcohol Use, Methamphetamine, and Underage Marijuana Use; and 1 campaign in FY 17/18: RX Drug Misuse

- Grew email reach to 400 community members and front line workers.
- Provided education to 40 alcohol/tobacco retailers:
  - ♦ 18 tobacco compliance checks completed
  - ♦ 15 Alcohol compliance checks with local law enforcement
- ♦ Held 2 Naloxone trainings in calendar year 18–15 kits were distributed
- ♦ September 2018 Community Marijuana Forum— 35 individuals attended
- ♦ February 2018 Voices of Recovery Meth- 73 attended
- November 2018 Conducted second student poster contest to engage students across seven districts in prescription drug campaign. 9 posters were submitted from three school districts.
- ♦ Collected 732 pounds of prescription drugs at prescription drug take back boxes during FY2017-2018
- Collected an additional 190 pounds at October 2017 DEA National Prescription Drug Take Back Day
- Co-hosted Intersection of Domestic Violence & Substance Abuse Conference with Family Violence Taskforce 89 attended
- ♦ Hosted 5 Mental Health First Aid trainings
- In April 2018, collaborating with libraries, sponsored and hosted One Book, One County Event focusing on Opiate Addiction. Brought in John Temple of West Virginia University. 140 books distributed /183 attended.

#### **Strategic Planning**

The St. Joseph County Human Services Commission Membership engaged in strategic planning with consulting firm Omni Tech International, Ltd in 2017 to determine how our collaborative can best serve the people of St. Joseph County.



#### Implementing a Strategic Plan for 2017-2020

While much of our strategic plan focuses on changes internally to strengthen communication within our collaborative as well communication with other bodies and agencies in SJC. The end result will be more residents receiving services because both the front line workers serving them know what is available in our county and residents will know how to access these services.

#### Strategic Plan Items Accomplished in 2018

In 2018, HSC chartered a communication committee, launched a new website with a county wide human services calendar, produced an annual report with outcomes of each workgroup, communicated results of the needs assessment and HSC strategy, optimized HSC meetings, and tracked connections made and needs resolved within the SJC Resources Google group.

#### Focus for 2019

HSC will address the lack of housing in St. Joseph County. A forum will take place for the community to come together to share and collect data to start building a community housing plan.
