#### Mission & Vision

The MISSION of the SJC HSC is to "coordinate and leverage collaborative efforts to improve the quality of life for all citizens."

Our VISION is to facilitate "seamless and efficient access to services that support individual, family, and community needs."

#### The Purpose of the HSC

The St. Joseph County Human Services Commission (HSC) was established by the St. Joseph County Commission in 1995 as the single multi-purpose collaborative for St. Joseph County. Their resolution authorized SJC Human Services Commission to:

- Forge alliances
- Create a shared vision
- Mobilize resources for services to families whose needs are being met by multiple agencies

Currently HSC is comprised of 18 member agencies working together to coordinate health and human services across systems. HSC fosters collaboration and relationships among agencies to prevent duplication of services and provide better service to our citizens.

The HSC does this work through established task forces and workgroups.

#### Brott Recognized as Health Hero and Honored by Michigan Health Week Partnership

**LANSING, MI** – As part of National Public Health Week, 15 individuals and organizations were presented with the 2019 Hometown Health Hero and Jean Chabut Health Policy Champion awards for their contributions to protecting and improving the health of Michigan residents on April 10 at the state Capitol.

The Michigan Public Health Week Partnership hosted the event to honor those who are helping Michigan achieve its goal of "Creating the Healthiest Nation: For science. For action. For health." This year's awards focused on healthy communities, violence prevention, rural health, technology and public health and climate change.

"The work of public health belongs to all of us," said Robert Gordon, MDHHS director. "Today I'm honored to celebrate a few individuals who have pointed the way. Some are Democrats, some are Republicans. Some are health professionals, some are regular citizens who lives have been touched by tragedy. Some work in Detroit and some work in northern Michigan. All have found a way to make our people healthier and our state stronger."

#### Laura Brott – St. Joseph County Human Service, Centreville

Brott has found innovative ways to connect service providers with the residents in St. Joseph County in need of their services. She was integral to a website redesign that integrated a community calendar and the development of a comprehensive resource guide for service providers so appropriate referrals could be made beyond their own agencies. Annually, she has been instrumental in coordinating the annual Project Connect/Veterans Stand Down event; putting residents in touch with county services, health screenings, vaccinations and food assistance.





#### The SJC Resources Google Email Group

was created among the task forces and workgroups in November 2016 and has grown to 430 caring individuals and professionals working on the front lines in St. Joseph County across many human services agencies, groups, and faith based organizations. The group email service is used to share agency updates, upcoming events, and request help finding a service or meeting a need.\*

## **2019 Project Connect** & Veteran Stand Down

Project Connect is a collaboration of the SJC Human Services Commission, its task forces, and other agencies serving St. Joseph County. The 13th Annual Project Connect was held October 4, 2019 at the Centreville Fairgrounds in Centreville. It was held in conjunction with a Veteran Stand Down.

#### **Event Impact:**

- 342 households attended
- 865 persons were Impacted (includes household members not present)
- 87% of attendees reside within St. Joseph County
- 279 out of 287 households indicated they received help they needed or were connected to a resource to help with their current needs
- 205 new households attended that did not attend in 2018
- 231 households attending in 2018 did not return to 2019 Project Connect
- 88 veterans attended
- Average household size was 3 persons
- Average age of attendee was 46-55 years old
- 16% of households had less than 12 years of education
- 19 households currently homeless
- 11 households in process of being evicted
- 123 attendees currently unemployed
- 69% of attendees sought food assistance
- 23% of attendees sought healthcare assistance

Project Connect is a community resource fair for individuals and families who are low income, homeless, and/or veterans to give them a hand up and improve their quality of life. Free items, services, information, and help is available on site at this one-day event.

- 17 rides provided to and from event courtesy of SJCTA
- 500 meals served
- 102 haircuts provided
- 88 service agencies participated
- 342 hygiene kits provided
- 342 community help cards distributed
- 14,133 1bs. pounds of fresh food distributed through Fresh Food Initiative
- 378 food boxes distributed
- 178 shots administered
- 363+ health screenings provided

This interdisciplinary team of medical staff, law enforcement, and other professionals review child deaths within St. Joseph County to determine if these deaths of 0-18 years olds were preventable. When appropriate, they suggest community-wide prevention education to prevent future deaths.

- ♦ 15 cases were reviewed in 2019.
- ◆ Prematurity, drowning, fire, and suicide contributed to preventable deaths of children reviewed in 2019.

The SJC Great Start Collaborative/Early Childhood Workgroup continued implementing its 4-year strategic plan.

- Awarded 24 preschool scholarships for three year olds in St. Joseph County (FY18/19).
- Partnerships with 6 childcare/preschool providers.
- ♦ Held 4 playgroups each week in four different communities.
- ♦ Launched the Great Book Hunt to promote summer reading.
- Held one community baby shower with safe sleep and shaken baby syndrome trainings. 80 families were educated and 63 gift bags were given away at the Fall event.
- ♦ 350+ attended Mom2Mom Sale/Baby Expo. 52 Sellers and 10 Community tables, and 4 educational sessions.

- ♦ 125 homeless people on Point-In-Time Count Day
- 600 literally homeless people served in St. Joseph County in 2019
- ♦ 434 children served in shelter
- ♦ 597 people served with rent assistance, equaling \$468,663.31
- ♦ 244 households served with utility & security deposit assistance equaling \$134,387.64
- ♦ Emergency housing assistance provided for 698 people

HSC addressed the lack of housing in St. Joseph County by holding a community forum and pursuing a community housing plan.


