The Purpose of the HSC

The St. Joseph County Human Services Commission (HSC) was established by the St. Joseph County Commission in 1995 as the single multi-purpose collaborative for St. Joseph County. Their resolution authorized SJC Human Services Commission to:

- Forge alliances
- Create a shared vision
- Mobilize resources for services to families whose needs are being met by multiple agencies

Currently HSC is comprised of 19 member agencies working together to coordinate health and human services across systems. HSC fosters collaboration and relationships among agencies to prevent duplication of services and provide better service to our citizens.

The HSC does this work through established task forces and workgroups.

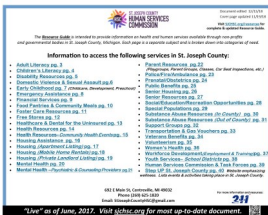

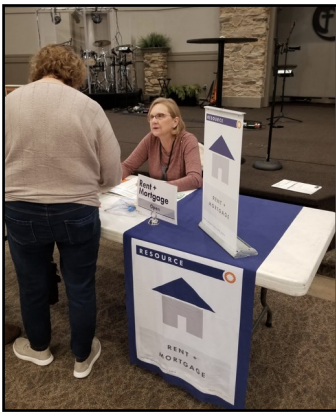
The HSC calendar of supportive events and services includes community events, food pantry and free store hours, support & recovery groups, and much more. Users can add events directly to their own calendars from the site.

The St. Joseph County Human Services Commission partnered with Hope United and St. Joseph County United Way November 17, 2022 to present a COPE Event: Cost of Poverty Experience at Firm Foundations Ministries.



The Cost of Poverty Experience (COPE) helps organizations, agencies, and ministries work more effectively with low-income families. COPE gives participants and volunteers an opportunity to experience poverty firsthand through the eyes of real families. The experimental nature of this training helps address the issues of poverty comprehensively.

This understanding leads to improved practices and approaches to better engage with low-income individuals. It also helps our community build broader partnerships to improve outcomes for low-income families.

Hope United led the efforts to organize this event. St. Joseph County United Way provided lunch for both attendees and volunteers and donated \$1,000 toward the cost. St. Joseph County Co-op also donated \$2,000 toward the cost. Firm Foundations donated the use of their facilities.

- 79 Individuals signed up to attend the event
- 17 community resource leaders facilitated

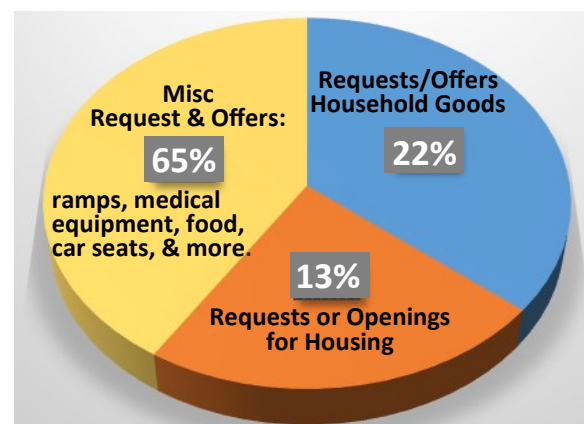
Hope United hopes to hold annual COPE events and desires to continue partnering with United Way and the HSC on these events.

2022 Project Connect & Veteran Stand Down

Project Connect is a collaboration of the SJC Human Services Commission, its task forces, and other agencies serving St. Joseph County. The 16th Annual Project Connect was held October 7, 2022 at the Fairgrounds in Centreville. It was held in conjunction with a Veteran Stand Down.

Event Impact:

- 168 households attended
- 447 persons were impacted (includes household members not present)
- 94% of attendees reside within St. Joseph County
- 139 out of 140 households indicated they received help they needed or were connected to a resource to help with their current needs
- 97 new households attended that did not attend in 2021
- 35 veterans attended
- Average household size was 3 persons
- Average age of attendee was 46-55 years old
- 12% of households had less than 12 years of education
- 15 households were currently homeless
- 2 households in process of being evicted
- 47 attendees currently unemployed
- 66% of attendees sought food assistance
- 27% of attendees sought healthcare assistance

Project Connect is a community resource fair for individuals and families who are low income, homeless, and/or veterans to give them a hand up and improve their quality of life. Free items, services, information, and help is available on site at this one-day event.

At 2022 Project Connect:

- 11 rides provided to and from event courtesy of SJCTA
- 420 meals served by St. Joseph County United Way
- 75 service agencies participated
- 200 hygiene kits provided
- 200 community help cards distributed
- 250 commodities boxes and 200 fresh food boxes distributed
- 72 shots administered
- 260+ health screenings provided

Collaboratively accomplished:

- ◆ Relayed COVID information to the healthcare workers, the public, and at-risk populations during the pandemic regarding CDC recommendations, testing sites, and vaccinations.
- ◆ Shared information regarding access to new health services in the county.
- ◆ Collaborated to efficiently provide vaccines and raise the level of vaccination in St. Joseph County. The group utilized a grant obtained through St Joseph County United Way to provide incentives for vaccination and vaccine hesitancy education.
- ◆ Increased community access to health services by providing outreach to hard-to-reach populations including the homeless, prisons, Amish, Hispanic, and others through mobile health services.
- ◆ Organized daily health presentations at the St. Joseph County Fair's Community Tent featuring these topics: early childhood programs, Marijuana: Knowing the Risks for Teens, Supporting Seniors: Promoting Independence, Stress and Women's Health, health screenings, and ESA service dogs.
- ◆ St. Joseph County United Way arranged a group strategic planning session. The group also provided input to the Sturgis Community Foundation regarding health criteria for a community dashboard and met with an independent consultant to develop a Community Health Improvement Plan for the health department in 2023.

This interdisciplinary team of medical staff, law enforcement, and other professionals review child deaths within St. Joseph County to determine if these deaths of 0-18 years olds were preventable. When appropriate, they suggest community-wide prevention education to prevent future deaths.

- ◆ 6 cases were reviewed in 2022.
- ◆ A house fire and vehicular accidents contributed to preventable deaths of children reviewed in 2022.

Collaboratively accomplished:

The SJC Great Start Collaborative/Early Childhood Workgroup continued implementing its 4-year strategic plan.

- Continued the Talk, Read, Sing community campaign.
- Distributed 320 Ready Calendars to support school readiness skills at home.
- Offered 6 Conscious Discipline classes with 51 participants completed.
- Launched Help Me Grow St. Joe website to the community. Began to market Help Me Grow St. Joe with reach cards, magnets, and other materials.
- Screened 556 children with the Ages and Stages Questionnaire online system. Added a Family Access portal on the Help Me Grow St. Joe website enabling caregivers to screen their children at any time.
- Held 6 Book-Walks, in partnership with the Three Rivers Library, throughout the summer on Memory Island, and The Huss Project. The GSC supported Centreville Elementary to start their own Book-walk at the school.
- Continued the Trusted Advisor work focused on building early literacy skills with 4 Musical Storybooks and Music Together Family classes in partnership with Three Rivers Library, Kalamazoo Symphony Orchestra, and The Huss Project
- Held weekly Playgroups at The Huss Project and Grace Christian Fellowship, Sturgis. Began Eaters-to Readers parent education program after playgroup at the Huss Project to engage families in the community garden at the Huss Project and learn about healthy eating.
- Distributed 250 Welcome Baby Bags to new parents thru Beacon-Three Rivers Hospital and Bronson Hospital as a collaboration grant from the Exchange Club of Sturgis, and support from St. Joseph County Child Abuse and Neglect about parenting tips and local community resources.
- Hosted the "Celebrating Babies" community event for pregnant mom's and those parenting children under 1 year along with BHSJ Health Department, with 10 exhibitors.

2022 Statistics

- ◆ 70 homeless people on Point-In-Time Count Day
- ◆ 300 literally homeless adults served in St. Joseph County in 2022
- ◆ 56 children served
- ◆ 453 households served by CERA other homeless prevention programs, equaling \$2,017,295.00 (This includes rent and utilities.)
- ◆ 35 households with 24 children served by rapid rehousing programs equaling \$183,596.00
- ◆ Over 120 cases coordinated through Interagency Services Team with focus of minimizing barriers to help people get housed and stay housed
- ◆ Used Mental Health grants to house 41 households with severe and persistent mental illness
- ◆ 168 families impacted through Project Connect (447 total persons in households)

Collaboratively accomplished:

- Oversight to our county's Housing Assessment and Resource Agency (Keystone Place); money received, spent, and outcomes to assure a comprehensive community-wide service and housing delivery system.
- Hope United and it's member churches established RESET Day Center in Centreville to support and assist Keystone Clients, the homeless, and those at risk for homelessness. RESET helps individuals with such tasks as: obtaining essential documents like birth certificates and I.D.'s, completing job and apartment applications, and also provides classes on basic financial training and life skills.

- ◆ Task force was instrumental in promoting prevention education throughout the year.

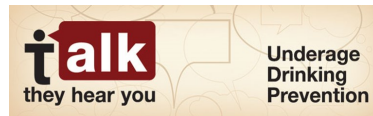

Collaboratively accomplished:

Held 5 campaigns in FY 21/22: Methamphetamine, Underage Alcohol Use, and Underage Marijuana Use, RX Drug Misuse, Underage Vaping

- ◆ Grew email database to reach over 600 community members and front line workers.
- ◆ Social Media interactions: over 5,000 people reached on Facebook. Joeinsider.com ads reached 14,000 views per month.
- ◆ Expanded community sectors representation on Task Force.
- ◆ Created a Spanish Facebook page and established a Spanish speaking person to manage the page
- ◆ Increased school appearance with Too Good For Drugs program.
- ◆ **Alcohol/ Compliance Checks (to prevent distribution of products to individuals under age of 18)**
 - ◆ Provided education to 73 alcohol/tobacco retailers.
 - ◆ Completed 30 retailer alcohol compliance checks (29 passed).
 - ◆ Completed 71 tobacco retailer compliance checks (70 passed).
- ◆ **Opioid / RX Drug Mis-Use Campaign**
 - ◆ Campaign flyers reached 10,060 people on Facebook;46 individuals viewed virtual presentation about RX overdose.
 - ◆ Held Naloxone Training for the public. All fire departments in St. Joseph County are trained and re-stocked with kits.
 - ◆ 1,760 pounds of medication collected at drop off locations.
- ◆ **Methamphetamine Campaign**
 - ◆ 2022 Voices of Hope and Recovery Event for Meth Campaign– 48 in-person attendees / also offered live stream.
- ◆ **Underage Drinking Campaign**
 - ◆ Facebook posts reached 10,924 people.
 - ◆ Eddie Mackay presented at Riverside Church, 44 attended.
- ◆ **Underage Marijuana Use Campaign**
 - ◆ Facebook posts reached 9,095 people.
 - ◆ County Fair presentation– 13 attended / 775 individual interactions at educational booth.
- ◆ **Underage Vaping Campaign**
 - ◆ Reached 15,415 people through Facebook posts.
 - ◆ Gave presentations to Colon MS, Colon HS ,and Sturgis football teams.
 - ◆ Ran 90 thirty second commercials on both WBET and WTHD radio.
- ◆ **Continued Prime For Life Curriculum**
 - ◆ Served 155 individuals in Prime for Life classes.
 - ◆ Served 9 Juvenile Day Treatment Center students in program.
 - ◆ Created all posts and flyers in Spanish and English. Offered a virtual option in Spanish.



Strategic Planning



Much of our strategic plan for 2022 focused on changes internally to strengthen communication within our collaborative as well as communication with other bodies and agencies in SJC. The end result is residents are receiving services because both the frontline workers serving them know what is available in St. Joseph County and the residents know how to access these services.

Strategic Plan 2022 Accomplishments

HSC addressed the lack of housing in St. Joseph County by collaborating with municipalities, chambers of commerce, and agencies to develop a community master housing plan under the guidance of the South Michigan Planning Council. The plan was completed in 2021 and a SJC Housing Collaborative workgroup formed. In 2022 the work group completed a series of one page guides for directing the public and businesses to housing resources. It then requested the County hire a full time housing Collaborative Coordinator to lead the continuation of the housing plan work. Through a grant award, the county has agreed to fund a Housing Collaborative Coordinator position starting in 2023 for two years.

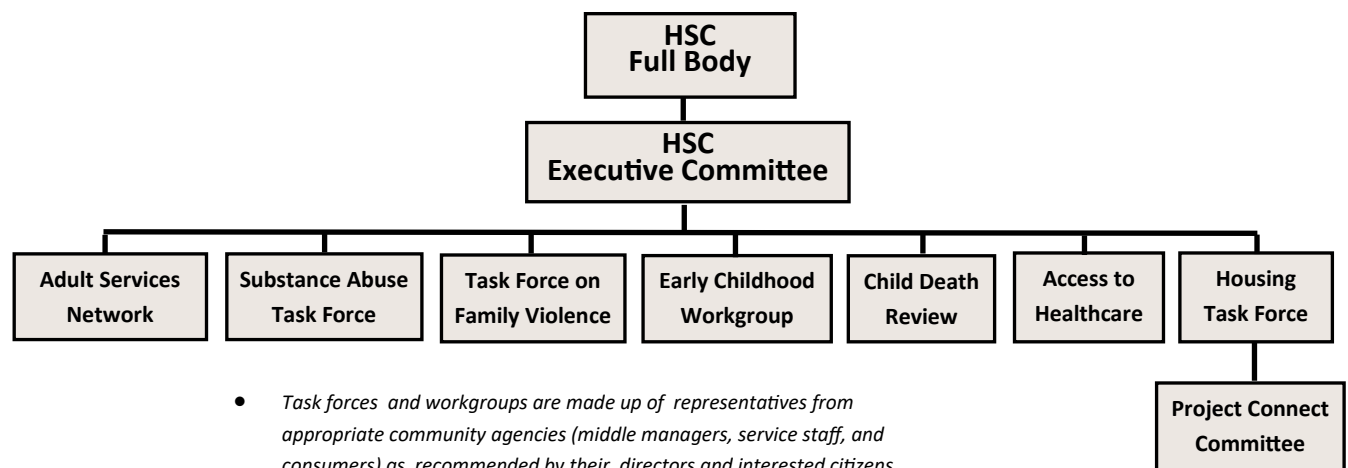
In 2022, the HSC's website of connection tools (including the community resource guide and community help card) along with its Facebook page and SJC Resources Google Group were an integral part of informing the community of services and events.

Focus for 2023

Housing continues to be a priority. The Housing Plan work group will start work with the new Housing Collaborative Coordinator to work on the county-wide housing plan. The HSC is working with the Sturgis Area Community Foundation on a Quality of Life Dashboard for our county. The HSC will also continue to build its network with community groups and marketing its resources website to agency workers and the public, county-wide.
